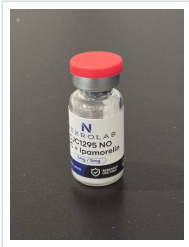

BLEND COMPOSITION share of total net peptide content

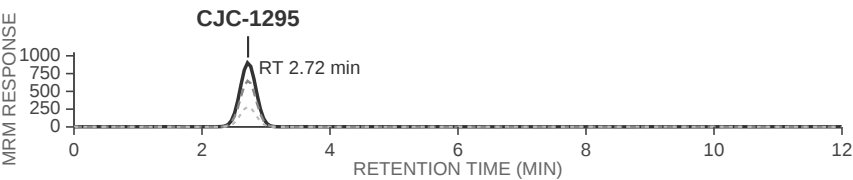

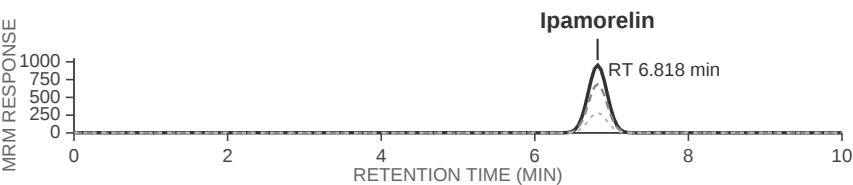
